Tax Payments

Tax payments may be made during normal business hours at the Town of Rhine Hall at W5250 CTH FF on Tuesday or Thursday from 11:30AM to 4:00PM. Tax payments may also be deposited in the drop box outside the Town Hall at any time. The drop box is located to the left of the front door.

Tax payments may also be made at the Elkhart Lake branch of Wisconsin Bank & Trust during normal lobby hours. Please bring along all tax bills with you to the bank when making payment.

For tax payments by mail, please use the following address and include a self-addressed stamped envelope if you require a receipt:

Dog Licensing

All dogs that are five months or older MUST be licensed before April 1, 2018. License fees for male & female dogs are \$14. License fees for spayed or neutered dogs are \$7. Multiple dog tags are \$55.

No dog license can be issued without a rabies vaccination certificate.

If you no longer have a dog that was licensed in the Township last year, please call 920-876-3413 so we can remove the dog from our records.

Payment of Dog Licenses may be made during normal business hours at the Town of Rhine Hall at W5250 CTH FF on Tuesday or Thursday from 11:30AM to 4:30PM. Dog license payments, including a self-addressed stamped envelope for mailing the license back to you, may also be deposited in the drop box outside the Town Hall at any time. For Dog License payments by mail, please use the following address and include a selfaddressed stamped envelope so the dog tag may be mailed back to you:

Notes from the Chair!

"New Ladder Truck"

For the last several years, the Elkhart Lake/Town of Rhine Fire Department has been requesting that the Joint Emergency Service Committee consider looking at the purchase of a new 100' ladder truck. (This request was made based on the fact that the old 55' truck was 33 years old, needed several expensive repairs and was really inadequate for many of the newer structures being built today.) Earlier this year that Committee instructed Fire Chief Pat Zorn to get us some numbers on the costs of a new truck and to possibly look if there were any good used trucks out there. In August, the Chief and several of his firefighters went to Bryn Mawr, PA to look at a used truck that they had located. After doing a thorough inspection of the truck, (a 2009 Rosenbauer Spartan 100' aerial), they returned and gave a power point presentation to a joint meeting of the Village Board and the Town of Rhine Board.

After determining that the cost of a brand new 100' aerial truck would be in the neighborhood of \$900,000 to one million dollars, they recommended to the joint boards that we consider purchasing the used truck at a cost of less than \$500,000. Because past Town Boards always budgeted monies ahead of time and held them in reserve accounts, we will be able to pay our half of the cost of this truck without additional taxes or borrowing.

This truck has very low mileage and very little use. It also has most of the equipment and storage requirements that they would like to see on a different aerial truck.

We have since entered into an agreement to purchase this vehicle and will be picking it up in June of 2018 to put into service here in our Joint Fire Department.

I would like to commend Chief Zorn for all of his efforts, and also his firefighters, for their input into reaching this resolution. I am confident that this is a good decision and this vehicle will serve our communities well for many years to come.

Long Range Planning Commission

Several months ago the Town Board took action to form a Long Range Planning Commission to update our Long Range Plan that was first implemented in 2009. We are required by the State of Wisconsin to update this plan every 10 years. (They are not looking at rewriting the existing plan, but simply adding addendums where changes need to be made.)

I want to thank those who stepped up to serve on this Commission and to invite you to attend any of their meetings if you have any input or are curious as to what they are doing. Their meetings are posted at the Town Hall and on the Town website.

Annual Budget

The Finance Committee is finishing up our work on the 2018 proposed budget for the Township. The new proposed budget will be presented to the residents of the Township at our annual meeting on November 15, 2018 at 6:30pm at the Town Hall.

RECYCLING CENTER


