The Town of Rhine Special Town Board Meeting was called to order by Chairman Platz at 6:15 p.m. at the Rhine Town Hall, W5250 CTH FF, Elkhart Lake, WI.

Town Board Supervisors present: Ron Platz, Allen Feld, Jon Rost, Bill Jacob and Larry Eberle. The Clerk/treasurer was also present.

1. **Approve 2019 Highway expenditures:** A motion to approve the 2019 Highway expenditures as recommended by the Special Meeting of Electors was made by Feld. 2nd by Jacob. Discussion: None. Motion carried with no nay votes.
2. **Approve 2018 Budget:** A motion to approve the 2019 Budget as recommended by the Special Meeting of the Electors was made by Feld. 2nd by Rost. Discussion: None. Motion carried with no nay votes.

Paul Booher asked if there was consideration given to making a donation for Rehab. The town has increased the dollar amount in this category in order so that donations to the lakes, etc. can be considered. Booher inquired if the town had received an answer about the legality of donating to a school. Legal counsel has advised that a donation to a school is legal. However, it could set an unwanted precedent for different reasons. Booher also inquired if any there were funds in the proposed budget to allow for possible pay raises for the poll workers. Platz explained that there are only 2 elections next year, not 4, but the budget remains the same in this category, so there could be funds to possibly make some changes in this area. A motion to approve the proposed budget as presented was made by Feld. 2<sup>nd</sup> by Rost. All in favor.

3. **Adjournment:** At 6:21 PM, a motion to adjourn was made by Feld. Second by Rost. Motion carried with no nay votes.
